<p style="text-align: center;"><b>1st Offense</b></p> Illegal Dig-Up non-refundable and the contractors name be placed on a list	\$1,000.00
<p style="text-align: center;"><b>2nd Offense</b></p> Violators should be suspended from DWSD for one year period Pay a reinstatement fee before their name can be removed from list	\$3,000.00
<p style="text-align: center;"><b>3rd Offense</b></p> Be placed on a non-compliance list and must pay all above fees plus place a retainer to be held against any further violations for five years	\$5,000.00
